The undersigned is informed and believes that:

COUNT 1

On or about June 28, 2014, defendant(s) GREG W did commit a felony namely: POSSESSION OF A CONTROLLED SUBSTANCE, a violation of Section 11350(a) of the Health & Safety Code of the State of California, County of Solano, in that said defendant did unlawfully possess a controlled substance, to wit, OXYCODONE.
